Profession

My Profession is in the area of Human Rights. I'm well-known for my longstanding track record on areas of Human Rights of African communities and ethnic minorities in Belgium, Europe and Africa for the last 30 years.

It all started within a local African diaspora organisation "Trajets pour la Reconstruction du Kasaï asbl" where community organisation and advocacy for minorities took my passion in the wellbeing of the less privileged. Growing from there I sat on various boards of directors of various organisations such as the former Council of African Communities in Europe, the second federating entity of Africans in and in Belgium (CCAEB), In 2014 I joined the founding of European Network of People of African Descent (ENPAD) where I had been coordinating the advocacy group for 1 year.

In 2019, with other experts, we co-founded the People of African Descent of Belgium Observatory (PADBelgium Observatory) which is an organisation dedicated to advocating for the human rights of People of African Descent in Belgium and the implementation of the programs of the United Nations framework of the Decade for People of African Descent by Belgian authorities and government and Europe.

As a feminist and African activist, I stand for girls and women's rights since 2004 as chairwoman of the former Network of Immigrant and Foreign Women of Belgium. Strong advocate for peace I founded the initiative "[Women for Peace in the World](#)" in 2015 an initiative that organizes and supports various activities and action led by women in the world to empower, advocate, educate, produce-analyze and foster peace building within communities.

I'm a social entrepreneur and associate consultant at Gender Innovation Accelerator (GIA), a technology company that fights gender-based violence through innovative technologies. Commercial trading consultant at USV – Representações, Consultoria em Metalurgia e Energias Renováveis, Lda based in Portugal. Passionate about Art, she created ArtDéCycles, a traveling art gallery. She also produces the weekly

cultural and musical radio show "Africana", continuing the work of its founder the late François Kasongo Mulenda.
