

Vision

Our vision is for every African and African Diaspora person to be able to fully enjoy all human rights and fundamental freedoms on basis of equality as declared in international Treaties and to eliminate Socio-economic disparities and marginalization of People of African Descent. Establishing a Global Diaspora Presence

Global Headquarters

The AUADS High Council established its global Headquarter in The Hague, Netherlands, with the aim to serve as the central hub for its operations and initiatives.

Regional Offices

Regional offices are to be established in: Africa, Asia, Brazil, Europe/EU, Caribbean/Rest of South America, Australia/New Zealand, Haiti, Latin/Central America, North America, Oceania/New Caledonia and Middle East. The purpose of the Regional offices is to ensure a strong local presence and connection to communities.

Commissions

The AUADS High Council Organization is a community-, commission-, expertise and competence driven govern structure. Commissions are created to ensure the effectiveness of the various aspects related to the implementation of the AUADS Sixth Region High Council Program of Actions.

Governing Bodies

The AUADS High Council's governing model includes: the General assembly (The Rotating President); High Commission on Strategic & Diplomatic Affairs (Officers Political; Economic and Social Cooperation). Executive Council for Operational Affairs; Executive Bureau/Secretariat/IT, Al and Media Affairs; African Diaspora Development Agency (ADDA).

Commissioners/Committees

The Commissions and Committees are community-, expertise- & competence driven and are aligned with key frameworks such as mentioned in slides 9 & 10 with regards to slide 8.

Special Councils

These includes the Council of Eminent Persons (who because of their skills, networks, expertise, experience and achievements, have the capacity to make a positive contribution with regards to the promotion of the mission of the AUADS High Council); Council of Elders (for confidential matters, conflict management &problem-solving); Council of Traditional Leaders (The King-, Queen- and Chiefdoms), Council of Ambassadors (in connection with diplomatic missions) and Honorary Councils (for promoting the Economic Relations and Facilitating trade and investment Relations)

Mandated Regional High Councils

These are the Regional High Council Leading Facilitators responsible for the mobilization and organization of the Diaspora interest in their respective Region taking into account thet mission of the AUADS Sixth Region High Council Organization.

The African Union African Diaspora Declaration and Program of Action (2012)

The Global Diaspora Summit Declaration and Programme of Action was adopted in 2012 by the Heads of State and Government of the African Union, the Caribbean and South America after dialogues carried out between Africans on the continent and Representatives of the African Diaspora in various regions of the world, including North America, South and LATIN America, Europe and elsewhere. It was adopted as a strategic framework for delivering on Africa's goal for inclusive and sustainable development and is a concrete manifestation of the pan-African drive for unity and self- determination. It recognised the need to establishing a solid foundation for the rejuvenation of the global African family as an instrument of wider renaissance with the aim:

To realize the imperative of a sustained and coordinated approach and ownership of the African Diaspora related programmes and projects as to promote their effective implementation and impact;

To cooperate in the political, economic and social areas outlined in this Programme of Action, and implementation and follow-up modalities.

The Declaration and Programme of Action are the framework on which the AUADS Sixth Region High Council's High Commission on political, economic and social cooperation operates.







UN Durban Declaration & Program of Action 2001



The UN Durban Declaration and Program of Action was adopted at the World Conference Against Racism, Racial Discrimination, Xenophobia and Related Intolerance" held in Durban South Africa in 2001.

The Durban Declaration acknowledges that slavery and the slave trade, including the transatlantic slave trade, were appalling tragedies in the history of humanity not only because of their abhorrent barbarism but also in terms of their magnitude, organized nature and especially their negation of the essence of the victims, and further acknowledge that slavery and the slave trade are a crime against humanity and should always have been so, especially the transatlantic slave trade and are among the major sources and manifestations of racism, racial discrimination, xenophobia and related intolerance, and that Africans and people of African descent.

It recognizes that colonialism has led to racism, racial discrimination, xenophobia and related intolerance, and that Africans and people of African descent, and people of Asian descent and indigenous peoples were victims of colonialism and continue to be victims of its consequences. We acknowledge the suffering caused by colonialism and affirm that, wherever and whenever it occurred, it must be condemned and its reoccurrence prevented.







The UN Decade for People of African Descent 2015-2024, "Recognition, Justice and Development"

The International Decade for People of African Descent, 2015–2024, was proclaimed by the UN General Assembly in a Resolution (68/237) adopted on 23 December 2013. The theme of the International Decade is "People of African descent: recognition, justice and development".

This Decade, for which the Office of the United Nations High Commissioner for Human Rights (OHCHR) was designated as the lead agency, aims to strengthen actions and measures to ensure the full realization of the economic, social, cultural, civil and political rights of people of African descent, and their full and equal participation in society.

Under the theme "Recognition, Justice and Development", the Decade provides an operational framework to encourage States to eradicate social injustices inherited from history and to fight against racism, prejudice and racial discrimination to which people of African descent are still subjected
