is our motto with which our High Council Organization wishes to welcome you, inspire you and inform you about who we are, our vision, mission, strategies, the basic principles as well as about the "Leave No Community Behind Ubuntu Connected Governance Organization Model".

In short: the AUADS Sixth Region High Council aims to strengthen collaboration and promote development initiatives between Africa and the Diaspora. It is an outcome of the Regional Consultative process between the Diaspora and the African Union, initiated by the African Union in 2005. Our Council recognizes the significance of harnessing the collective power and resources of the African Diaspora to drive socio-cultural and economic progress, poverty eradication, education and scientific research, healthcare, digital & technological advancement and sustainable development within both Africa and the Diaspora. Our Council strongly advocates for Reparatory Justice for the Crimes against Africa and African People in context of the trans-Atlantic slave trade, chattel slavery and colonialism, as well as the "Right to Return". These are issues of high importance. The official launch of the establishment of the AUADS Sixth Region High Council Organization took place on July 10th, 2023 in Maputo, Mozambique in the presence of the Minister of Foreign Affairs and Cooperation, Her Excellency Veronica Nataniel Macamo Dlhovo. This follows a development, mobilization, and organizing process that began in 2007.

Why the launch in Maputo?

Maputo was the city where on July 11th, 2003 the African Union (AU) Heads of State officially adopted Article 3q of their Constitution by which the African Diaspora are invited and encouraged to the full participation as an important part of the African continent, in the building of the African Union. This Article 3q lays the groundwork for the official integration of the African Diaspora into the African Union as the Sixth Region.
